SINGLE ELIMINATION

A. GENERAL INFORMATION

1. The National Federation Ice Hockey Rules shall govern all Shore Conference games.
2. The Tournament Director must be notified by the winning team at the completion of all games.

B. TEAM SELECTION

1. The cut-off will be Friday 2/19; games played on 2/19 will count for seeding purposes.
2. All Division games must be played prior to the cut-off date.
3. Seeding meeting Saturday 2/20 at 10:00am @ Brick Twp. High School.

C. ENTRY FEE

D. RINK SITES

1. Sites for the first two rounds will be at the RINK of the higher seeded team as determined by the seeding committee.
2. Championship Games will be played at: Winding River Ice Rink

E. GAMES

1. The home team will wear white jerseys throughout the tournament.
2. The visiting team must bring both jerseys to each round of play.
3. For the Finals-The higher seeded team will be the home team and wear white jerseys.
4. The game will consist of three 15 minute periods.
5. If the game is still tied at the completion of the 3 fifteen-minute periods; A tiebreaker will follow.

F. TIE-GAME PROCEDURE (Tournament rounds 1 & 2)

1. There shall be one (5) minute sudden victory overtime period.
2. Teams will defend the same goal as for periods one and three.

IF THE SCORE REMAINS TIED AFTER THE OVERTIME PERIOD; A SHOOTOUT WILL FOLLOW;

G. SHOOTOUT PROCEDURE

A list of six (6) players, in order, shall be given to the referee prior to the overtime.

The choice to shoot first shall be determined by a coin toss.

The first three (3) players from each team alternate attempts at a penalty shot.

The team scoring the most goals wins by a one goal differential.

If score is tied after three (3) penalty shots, the second three (3) players attempt sudden victory penalty shots.

If necessary, the original list of six (6) players will begin again taking penalty shots (sudden victory) until the tie is broken.

During the shoot-out, teams shall remain at their benches and defend their goal.

A Disqualified player can not shoot and shall be replaced prior to the start of the shoot-out. Any injured player, whose name is on the list of players to shoot, may be replaced prior to the start of the shoot-out.

H. TIE GAME PROCEDURE FOR FINALS ONLY; tiebreaker will consist of one (5) minute sudden victory overtime period. If the score is still tied the teams will be CO-CHAMPIONS.

I. MEDIA

1. The winning team is responsible for notifying the Asbury Park Press and Star Ledger.

J. OFFICIALS

1. Game officials will be assigned by the Tournament Director for the Finals.
2. For rounds 1 and 2 it is the responsibility of the home team to schedule and pay the officials. The Shore Conference will pay for the officials in the Championship games.

K. SCHOOL RESPONSIBILITIES

1. Tournament Director must be notified when a tournament game is postponed because of inclement weather by the home team.
2. In all rounds of tournament play ATHLETIC DIRECTORS OR THEIR DESIGNEE MUST be in attendance for crowd control until the event is over.
3. It is the responsibility of the schools to complete their division schedules prior to the seeding meeting.

L. MEDICAL COVERAGE

1. Schools will be responsible for having a trainer present at all games. Please communicate with opponents Athletic Director to ensure a trainer will be available to cover games.

M. SEEDING COMMITTEE

The seeding committee will consist of 1 coach from each division from the hockey committee.
